In reference to the BID ID No **KCCB/5606/2023-24** & BID ID No **KCCB/5607/2023-24** dated 17.02.2024 is hereby extended to 12.03.2024 upto 4.00 PM and the opening of Technical Bid is also extended to 12.03.2024 at 5:00 PM. The eligibility criteria for the bidders are also modified and are mentioned below:

For both BID ID No **KCCB/5606/2023-24** & BID ID No **KCCB/5607/2023-24** those who qualify in Technical Bid will be called for a presentation at Keonjhar Head Office. The bidders will be intimated for presentation prior to 3 days. Presentation will be for 20 minutes inclusive of Question-and-Answer session. Bidders qualifying with 70% marks or more will be eligible for opening of the Financial Bid. The Qualifying Criteria in presentation will be as follows:

1. The Intending bidders should have executed works of at least:
For One similar nature work (80% of the total Project Cost)
For Two similar nature work (50% of the total Project Cost)
For Three similar nature work (30% of the total Project Cost)
In previous five(5) financial years.

(Note* Similar Nature works means- Buildings/Bridges/Major Irrigation Structures. A certificate to this effect must be enclosed from the officer not below the rank of Super intending Engineer or equivalent officer as per enclosed Schedule-D1 (Completed works) & Schedule- D2 (Ongoing works).

2. The Bidder should have Annual Financial Turnover of Value not less than 5.00 Crores during any one financial year of previous 5 Financial Years in respect to Civil Engineering Construction works.
3. The Clause Bid Capacity is hereby deleted.

~~Applicant(s) who meet the minimum qualification criteria will be qualified only if their available bid capacity at the expected time of bidding is more than the total estimated cost of the works mentioned in Contract Data. The available bid capacity will be calculated as under.~~

~~A= Maximum value of works executed in any one year (As reported and certified by Chartered Accountant) during the last five years (updated to the current price level (Base Year) as mentioned in the Contract Data) rate of inflation may be taken as 10 per cent per year (escalation factor) which will take into account the completed as well as works in progress, B= Value at current price level of the existing commitments and ongoing works to be completed during the period stipulated in the contract data (period of completion of works for which bids are invited); and~~

~~N= Number of years prescribed for completion of the works for which the bids are invited as mentioned in contract data. (For work completion period less than one year the value may be taken as one year)~~
